The tanks are also further required to be installed and commissioned so that the tanks are fully functional with running water.

Therefore, Sealed quotations are invited from reputed Firms empanelled with SIMFED for the following works in the various districts of Sikkim.

1. Carriage of LDPE Tanks (5000 ltrs - each tanks weighing 180 kgs) from the roadside the farmers field.
2. Installation of the tanks with complete accessories.

3. All Quotations are to be submitted to the General Manager (I), SIMFED, Development Area, Gangtok, East Sikkim 737101 by 12.00 Noon, 10/02/2023. After the stipulated time no quotations will be accepted.
4. Submission of the quotations assumes that the party has accepted all the terms & conditions and will accept the decision of management of SIMFED.
5. The rates submitted by the L1 shall be verified and if found abnormally higher than the prevailing rates of the market then the management reserves the right to cancel/ renegotiate or any other decisions that may be beneficial for the end buyer.
6. **Supply/ work order shall be given to the lowest bidder and after acceptance of the rates by SIMFED on the condition that the rates are further accepted by the indenting department and a Supply Order is issued by them in favour of SIMFED.**
