3. All Quotations are to be submitted to the General Manager-I, Development Area, Gangtok, East Sikkim 737101 by 12.00 Noon, 12/12/2017. After the stipulated time no quotations will be accepted.
4. The prescribed tender fee (as per the rate quoted) may be deposited along with the submission of quotations.
5. **Trade discounts being offered to SIMFED must be mentioned clearly in the quotations.**
6. Payment on successful supply will be made only after receipt of the payment from the indenting department and on satisfactory distribution at the places mentioned below and on receipt of report from the Sr. Welfare officer concerned. Involvement of the field Veterinarian of the concerned area in the purchasing committee is mandatory.
7. The vendor submitting the quotations must have cleared the processing fees and other dues with SIMFED Accounts Section.
8. Submission of the quotations assumes that the party has accepted all the terms & conditions and will accept the decision of management of SIMFED.
9. The rates submitted by the L1 shall be verified and if found abnormally higher than the prevailing rates of the market then the management reserves the right to cancel/ renegotiate or any other decisions that may be beneficial for the end buyer.
10. Supply order shall be given to the lowest bidder and after acceptance of the rates by SIMFED on the condition that the rates are further accepted by the indenting department and a Supply Order is issued by them in favour of SIMFED.

ANNEXURE-I

Milching Cow :

1. The breed of the Milch cows should be of Jersey cross breed with in 1st to 3rd lactation period and below the age of six years with average milk yield of 06 to 08 litres per day without any disease and vices & with better phenotypic and genotypic traits.
2. The cow should be free from all diseases with supporting certificate issued by Veterinary Doctor.
3. The Total cost quoted should cover up the following expenses too:
 - a. Actual expenses during selection and procurement.
 - b. Quarantine, transportation and allied expenses.
 - c. Feed/Fodders and medicine during transportation.
 - d. Training to beneficiaries on Dairy Management before distribution.
 - e. Insurance for three years per cow.
 - f. Monitoring and treatment by Veterinary Doctors.
 - g. Mineral, mixture and de-worming during distribution.
4. Pregnant Cows should not be supplied to the beneficiaries as this may endanger their lives during their transportation.
