- 1. The quotations must be submitted in a sealed envelope. NIQ reference No. must be written very clearly on the envelope.
- 2. Quotations only from the Empanelled manufacturers/ dealers/ suppliers of SIMFED shall be accepted. Empanelment must be valid (Expired empanelment shall not be accepted). Further, the empanelment must be at least one year old.
- 3. Quotations should be submitted with a detailed physical survey report along with the works to be undertaken at each of the above mentioned sub centre failing which the quotations shall be rejected.
- 4. The work has to be done according to the GOI guidelines AYUSH Man Bharat model & Branding.
- 5. All Quotations along with the physical survey report are to be submitted to the General Manager (I), SIMFED, Development Area, Gangtok, East Sikkim 737101 by 12.00 Noon, 27/01/2021. After the stipulated time no quotations will be accepted.
- 6. An amount of Rs. 10,000.00 may be deposited as Tender fees/ processing fees. This amount is unrefundable. The amount may be paid in cash (at the accounts section of SIMFED) or by Demand Draft in favour of the Managing Director, SIMFED. Cheques will not be accepted.

- 7. EMD @ 2.5% of the work value should be submitted in cash (at the accounts section of SIMFED) or by Demand Draft in favour of the Managing Director, SIMFED (Cheques will not be accepted) before release of the work order else the work order shall not be awarded.
- 8. The materials should be strictly as per the specifications and quantity mentioned.
- 9. Trade discounts being offered to SIMFED must be mentioned clearly in the quotations.
- 10. Payment on successful supply will be made only after receipt of the payment from the indenting department and on obtaining the completion certificate from the indenting department.
- 11. The vendor submitting the quotations must have cleared the processing fees and other dues with SIMFED Accounts Section.
