NOTICE INVITING QUOTATION (N.I.Q.)

Sealed quotations are invited from Suppliers (Empanelled with SIMFED for supply of Milching Cows with calf along with dairy equipments as per the guidelines laid by the indenting department as below;

Milching Cow:

- 1. The breed of the Milch cows with calf should be of Jersey HF cross breed with in 1st to 2rd lactation period and below the age of six years with average milk yield of 12 to 15 litres per day without any disease and vices & with better phenotypic and genotypic traits.
- 2. The cow should be free from all diseases with supporting certificate issued by Veterinary Doctor.
- 3. The Total cost quoted should cover up the following expenses too:
 - a. Actual expenses during selection and procurement.
 - b. Quarantine, transportation and allied expenses.
 - c. Feed/Fodders and medicine during transportation.
 - d. Training to beneficiaries on Dairy Management before distribution.
 - e. Insurance for three years per cow.
 - f. Monitoring and treatment by Veterinary Doctors.
 - g. Mineral, mixture and de-worming during distribution.

4. Pregnant Cows should not be supplied to the beneficiaries as this may endanger their lives during their transportation.

- 5. List of other equipments are as below:
 - a. Steel Milk Can (20 Litres)
 - b. Steel Bucket (10 Litres)
 - c. Feeding Trough
 - d. Medicine Kit
 - e. Sickle
 - f. Rope (1 coil)

Terms and conditions:

- 1. The quotations must be submitted in a sealed envelope. NIQ Reference no. must be written very clearly on the envelope.
- 2. Only Quotations from Empanelled suppliers/ Vendors of SIMFED shall be accepted. Empanelment must have valid period of atleast 1 month (Expired empanelment shall not be accepted).
- 3. The supplier/vendor submitting the quotations should have prior experience in supply of atleast 100 Milching Cows to any government departments in Sikkim. This should be supported by copy of successful completion certificate issued by Government Departments within 2 years.

- 4. The supplier/ Vendor shall forward Bank solvency certificate of Rs.50.00 lakhs.
- 5. All Quotations are to be submitted to the General Manager-VI, Development Area, Gangtok, East Sikkim 737101 by 12.00 Noon 10.08.2017 After the stipulated time no quotations will be accepted.
- 6. The prescribed tender fee of Rs. 15,000 only may be deposited along with the submission of quotations.
- 7. Trade discounts being offered to SIMFED must be mentioned clearly in the quotations.
- 8. Payment on successful supply will be made only after receipt of the payment from the indenting department and on satisfactory distribution at the places mentioned below and on receipt of report from the Sr. Welfare officer concerned. Involvement of the field Veterinarian of the concerned area in the purchasing committee is mandatory.
- 9. Places of distribution: as direction and list of beneficiaries framed by SJEWD within the State of Sikkim.
- 10. Procurement of cows shall be strictly as per technical guidance of Technical Officer nominated by SJEWD/ AH&VS department and random procurement will not be entertained.
- 11. Technical Officer will have overall control during the time of procurement for the aspects like breed, age, lactation details etc and disease, pest, infection, medication etc during the time of transportation and distribution.
- 12. The vendor submitting the quotations must have cleared the processing fees and other dues with SIMFED Accounts Section.
- 13. Submission of the quotation assumes that the party has accepted all the terms & conditions and will accept the decision of management of SIMFED.
- 14. The rates submitted by the L1 shall be verified and if found abnormally higher than the prevailing rates of the market then the management reserves the right to cancel/ renegotiate or any other decisions that may be beneficial for the end buyer.
- 15. Supply order shall be given to the lowest bidder and after acceptance of the rates by SIMFED on the condition that the rates are further accepted by the indenting department and a Supply Order is issued by them in favour of SIMFED.
- **16.** The management of SIMFED reserves the right to accept or reject any quotations without assigning any reasons thereof. The Decision of the Managing Director is final & binding on all in all circumstances & situation.
- 17. SIMFED RESERVES THE RIGHT TO CANCEL THIS NIQ AT ANYTIME.
