1. The quotations must be submitted in a sealed envelope. NIQ reference No. must be written very clearly on the envelope.
2. The Brand names and specifications of all the items have to be mentioned in the quotation (wherever applicable).
3. Quotations from Empanelled manufacturers/ dealers/ suppliers of SIMFED having valid empanelment shall be accepted.
4. The suppliers should have valid Trade License.
5. The suppliers should have valid Distributor/Dealership certificate.
6. The suppliers should have past experience of supplying similar items.
7. All Quotations are to be submitted to the General Manager(V), Development Area, Gangtok, East Sikkim 737101 by 12.00 Noon, 03/10/2017, i.e. within fifteen days from the publication of NIQ in the official website of SIMFED. After the stipulated time no quotations will be accepted.
- 8. The prescribed tender fee of Rs.2500/- may be deposited along with the submission of quotations.**
9. The quotations must be supported by Company's Price list and Dealership certificate.
10. After finalization, the Supply has to be completed within 20 days of time.
11. The suppliers should have a condition to replace the damaged items.
- 12. Tender opening committee shall comprise of official from SIMFED and the Intending Department for proper scrutinization of all documents.**
13. The quantities mentioned are subject to change.
- 14. Trade discounts being offered to SIMFED must be mentioned clearly in the quotations. The vendor offering the highest trade margin shall be given the preference.**
15. Payment on successful supply will be made only after receipt of the payment from the indenting department and on obtaining the completion certificate from the indenting department.
16. The vendor submitting the quotations must have cleared the processing fees and other dues with SIMFED Accounts Section.
17. Submission of the quotations assumes that the party has accepted all the terms & conditions and will accept the decision of management of SIMFED.
18. The rates submitted by the L1 shall be verified and if found abnormally higher than the prevailing rates of the market then the management reserves the right to cancel/ renegotiate or any other decisions that may be beneficial for the end buyer.
