1	Naturally Ventilated Tubular Structure Greenhouse	Naturally Ventilated type tubular structure green house with the central height 5 mtrs, complete fitting, fixing and using cladding with 5 layer UV clear film of 200 micron thickness (Ginegar) by means of aluminium/ GI profile and spring lock system along with the foundation work for fitting and fixing. The structure has to be zero energy naturally ventilated green house by using BIS make GI pipe of 48OD main column, 40 OD perlin and Arc 2mm thickness, with 1m. Apron along the greenhouse & 40 mesh insect proof net/50% Agro shade net below the curtain with rolling system for ventilation. The installation will be done in the farmers field and sizes of the structure will be as per the given specification/ suitability of the land available.	12,000 sq. mts	The locations of the green houses to be erected are in the South district of Sikkim.
