6. The firm quoting the lowest rate shall be awarded the job order if received from Intending Department.
7. The materials should be strictly as per the specifications mentioned.
8. **Trade discounts being offered to SIMFED must be mentioned clearly in the quotations.**
9. Payment on successful supply will be made only after receipt of the payment from the indenting department and on obtaining the completion certificate from the indenting department.
10. The vendor submitting the quotations must have cleared the processing fees and other dues with SIMFED Accounts Section.
